## ADOPTED AMENDMENTS TO DECLARATION OF COVENANTS AND RESTRICTIONS FOR EAST LAKE WOODLANDS WOODS LANDING TOWNHOMES UNIT ONE

(Additions indicated by underlining, deletions by "-----" and unaffected language by "...")

Adopted amendments to Article XII, to delete Section 12.03(e) and add a new Section 12.10, as follows:

## ARTICLE XII - MISCELLANEOUS

Section 12.03 - Developer's Rights. . . .

(c) With the consent of the persons then owning seventy five percent (75%) or more of the Lots, to amend or alter the Covenants and any parts thereof in any other respects, except that the provisions of Article VII, supra, may not be amended or altered under the provisions of this section.

Section 12.10 - Amendment of Covenants. The Covenants may be amended or altered by approval of a majority (50% plus 1) of the total voting members. Approval shall be given at a duly called meeting of the membership, at which a quorum is present, in person or by proxy.
