1. ARTICLE II, RESTRICTIONS, Section 2.14, Trees, of the Declaration shall be amended to read as follows:

No living tree having a diameter greater than four inches measured at a height of four feet above ground level, may be cut on any of the Land without first obtaining the written consent of Developer.
